

## ASSIGNMENT

WHEREAS, Cities Service Company, herein called Assignor, a Delaware Corporation, the address of which is P.O. Assignor does also hereby grant, convey, assign and deliver unto Assignee all of its right, title and interest in and to all personal property, machinery and equipment located on the properties described above.

Assignor does hereby warrant title to the leases described herein to the extent and only to the extent of the warranty received by Assignor when Assignor acquired its interests in said leases.
