THIS IS TO CERTIFY that the BAR # 631 lode mining claim was located by:

Said claim is located in the NE/4 of Sec. 1, Twp. 34 North, Range 51 East.
SE/4 of Sec. 1, Twp. 34 North, Range 51 East.
NW/4 of Sec. 6, Twp. 34 North, Range 52 East.
SW/4 of Sec. 6, Twp. 34 North, Range 52 East.

Beginning at Corner No. 1, the Northeast corner, which is located 1000 feet East and 1600 feet South from the NE corner of Section 1, Township 34 North, Range 51 East, Mount Diablo Meridian; thence,

South 600' to the SE corner, a PVC pipe 4" in dia. x 5' in length; thence,
West 750' to the South side center, a PVC pipe 4" in dia. x 5' in length; thence,
West 750' to the SW corner, a PVC pipe 4" in dia. x 5' in length; thence,
North 600' to the NW corner, a PVC pipe 4" in dia. x 5' in length; thence,
East 750' to the North side center, a PVC pipe 4" in dia. x 5' in length; thence,
East 750' to the NE corner, a PVC pipe 4" in dia. x 5' in length, the point and place of beginning.

We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 10 feet from the location monument in a Easterly direction, and 1490 feet in a Westerly direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The monumentation and marking of the corners was completed by the 3rd day of July, 1983.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the \$20.75 lode claim filing fee has been paid to the County Recorder.
