and all of the acts and transactions of the executor during the period of the account are truly shown and should be approved, and all the allegations of the petition for its settlement and for final distribution are true. The account is full, true, and correct, and should be settled, allowed, and approved as filed.

- (c) All personal property taxes due and payable by said estate, all debts of decedent, all claims against said estate, and all expenses of administration, except statutory commissions and fees and closing expenses, have been paid.
- (d) No federal estate tax return was due or required in this estate.
- (e) Executor should be authorized to pay herself the sum of \$1,819.82 as commissions for statutory services, and a like amount to her attorneys, Surr & Hellyer A Professional Corporation, as fees for statutory services.
- (f) Decedent died testate on October 10, 1982, a resident of the County of San Bernardino, State of California. All property in which decedent had an interest at the time of her death was her separate property. By her will, decedent disposed of all of her property.
