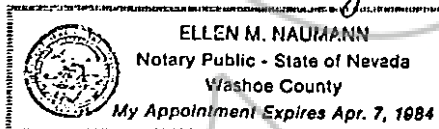

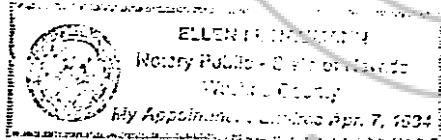

ATTACHMENT NO. 2Summary Report of Work Done
on the 40 Mary Claims

Work on Mary claims Nos. 21-60 of Sec. 20, T33N, R51E consisted of:

(1) mapping Section 20 in its entirety on aerial photos at the scale of 1" = 300' by Anthony A. Longo, (2) mapping the claims 49 and 50 at the scale of 1" = 50' by Kim V. Russell, and (3) geochemical sampling run for several elements. John Painter and John Watson surveyed in a grid (200' intervals N-S and 100' intervals E-W) in claims 49 and 50. The grid was utilized in mapping 1" = 50'. Both mapping projects precisely located numerous high-angle structures worthy of additional geochemical sampling.

A total of 57 samples were collected by all three professional geologists. These samples were assayed and geochemically evaluated for precious metals and the Au indicator elements by Hunter Mining Laboratory, Inc. Twelve geochemical soil samples were collected by John Painter in an easterly trend perpendicular to a major high angle structure. The soil samples were analyzed by Chemex Labs, Ltd., for precious metals and trace element indicators.

Basically the mapping and chemical results indicate good potential for continued sampling, detailed geological mapping, and reasonable targets for additional rotary drilling.

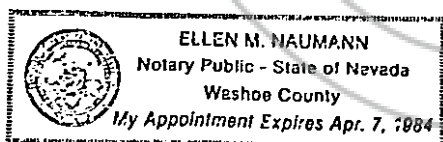
