

# Certificate of Location of Lode Mining Claim

The undersigned hereby certifies that he has located the WP No. 227  
Lode Mining Claim in the  
NW, SW Quarter, Section 30, Township 34 N, Range 51 E, M.D.B. & M.,  
in Eureka County, Nevada, on the 15th day of July, 1983.

The claim is 1500 feet long and 600 feet wide, and 10 feet is claimed  
in a North direction and 1490 feet in a South direction from the location  
monument, at which the Notice of Location is posted, lengthwise of the claim,  
together with 300 feet in width on each side of the center of the claim. The  
general course of the lode deposit and premises is from the North to the  
South.

The location and number of each corner of this claim is shown on the claim map  
that is filed herewith. On the ground, each corner of the claim is marked with its  
appropriate number by marking the claim name and number on an aluminum tag.

The description of each corner is as follows:

Northwest Corner No. 1 is a 4" x 4" x 4 1/2 ft. wood post.  
Northeast Corner No. 2 is a 4" x 4" x 4 1/2 ft. wood post.  
East Side Center No. 3 is a 4" x 4" x 4 1/2 ft. wood post.  
Southeast Corner No. 4 is a 4" x 4" x 4 1/2 ft. wood post.  
Southwest Corner No. 5 is a 4" x 4" x 4 1/2 ft. wood post.  
West Side Center No. 6 is a 4" x 4" x 4 1/2 ft. wood post.

The monumentation and marking of the corners was completed by the 24th  
day of July, 1983. This claim is intended to cover all open ground  
existing within its boundaries as of this date of posting.

The location work consisted of making a claim map as provided in NRS 517.040.  
Two copies of this claim map have been filed with the Eureka County Recorder,  
and the \$20.75 lode claim filing fee has been paid to the County Recorder.
