CERTIFICATE OF LOCATION---NEVADA

THE UNDERSIGNED, hereby certifies that LABRADEX CORPORATION, by its agent, the undersigned, a citizen of the United States, on the 5TH day of August, 1983 located the Mary no 11 Lode Mining Claim in accordance with the 1872 Mining Laws of the United States and all subsequent acts, the Mining Location Laws of the State of Nevada, and all local laws, customs, and regulations, and on that day posted a Notice of Location at the place of discovery.

Said claim is located in the Maggu Creek Mining District, Eureka County, Nevada about 3/4 mile in a NW 1/4 direction from Marys Mountain. This claim can further be described as being in Section(s) 08, Township(s) 33N, Range(s) 51E, M.D.B. & M.

The general course of said lode or vein is Easterly and Westerly and the locator claims 20 feet in an Easterly direction and 1480 feet in a Westerly direction from the point of discovery together with a width of 300 feet on each side of the center of the vein or lode along the entire length of said claim or a claim 1500 feet by 600 feet in size.

The location work consisted of the preparation of a map of said claim together with other claims in a common group as provided in NRS 517.040. Said map is being filed with and made a part of this Certificate, and was prepared from an actual field survey of this claim.

The corners and side-centers of this claim are located and marked as follows:

From the northeast corner, a post marked NE Corner No. 1: Mary no 11
thence southerly, 600 feet to a post marked SE Corner No. 2: Mary no 11
thence westerly, 750 feet to a post marked South S.C. No. 3: Mary no 11
thence westerly, 750 feet to a post marked SW Corner No. 4: Mary no 11
thence northerly, 600 feet to a post marked NW Corner No. 5: Mary no 11
thence easterly, 750 feet to a post marked North S.C. No. 6: Mary no 11
thence easterly, 750 feet to a post marked NE Corner No. 1: Mary no 11
the place of beginning.

Each of the above-described corners and side-centers are 4" by 4" wooden posts at least 4 1/2 feet in length, set one foot in the ground, and were erected on or before August 5, 1983.
