CERTIFICATE OF LOCATION --- NEVADA

THE UNDERSIGNED, hereby certifies that LABRADEX CORPORATION, by its agent, the undersigned, a citizen of the United States, on the 57# day of August ,1983 located the Mauric 16 Lode Mining Claim in accordance with the 1872 Mining Laws of the United States and all subsequent acts, the Mining Location Laws of the State of Nevada, and all local laws, customs, and regulations, and on that day posted a Notice of Location at the place of discovery.

Said claim is located in the Magga (rek Mining District, Eureka County, Nevada about 1/2 m, L in a NW'LY direction from Mago Mountain. This claim can further be described as being in Section(s) . Township(s) 33N , Range(s) SIE , M.D.B. & M.

Each of the above-described corners and side-centers are 4" by 4" wooden posts at least 4½ feet in length, set one foot in the ground, and were erected on or before $\frac{August 5}{2}$, 19 $\frac{83}{2}$.
