

AMENDED NOTICE AND CERTIFICATE OF LOCATION-MILL SITE- NEVADA

THE UNDERSIGNED HEREBY certifies, that EXXON CORPORATION, through its Employee and Representative, the undersigned, does hereby make and file this Third Amended Location of the MT 453 Mill Site, on this 19th day of July, 1983, and situated in the Mt. Hope Mining District, Eureka County, Nevada.

Said Claim is located in the NW (Quarter) Section(s) 13, Township 22N, Range 51E, Mt. Diablo P.M. and more particularly described as follows, to wit:

Beginning at the northeast corner post No. 1:

Thence 300 feet in a Southerly direction to post No. 2,
Thence 300 feet in a Southerly direction to post No. 3,
Thence 360 feet in a Westerly direction to post No. 4,
