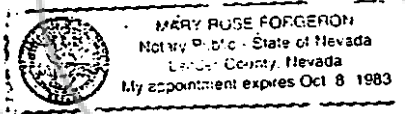

The following geologic report and accompanying map will serve as assessment work for the '82-'83 assessment year on Buck 1-3 claims located on the common corner of Sections 27, 28, 33, and 34, T23N R48E Eureka County, Nevada. Information as required by Public Law 85-876 (Act of September 2, 1958; 72 Stat. 1701) has been listed below:

1. Location of work performed in relation to point of discovery and boundaries of the claim.

A geologic map has been prepared showing the geology within and surrounding the claim group.

2. Type of work, extent and cost.

One and a half days were spent geologic mapping the Buck claims area on an enlarged copy at 1 inch = 200 feet of the 15' Walti Hot Springs Quadrangle prepared by the U. S. Geological Survey. One day was spent preparing this report and drafting the geologic map. Total cost of the survey is in excess of \$300.00.

3. Results of the survey.

The area is mapped as the Ordovician Vinnini Formation according to the Geologic Map of Nevada published by the U. S. Geological Survey. Sedimentary bedded barite and minor vein barite occur on the claim group. Geologic mapping has identified mineralized areas and delineated trends for further development.
