This report is in compliance with the Bureau of Land Management Circular
No. 2289, "Regulations Pertaining to Mining Claims Under the General Mining
Laws of 1982." (As contained in Title 43 of the Code of Federal Regulations.)
Subpart 5 3851.2, Inclusion of Surveys in Assessment Work.

Assessment work completed during the period from September 1, 1982 thru
September 1, 1983 consisted of detailed geochemical sampling and geologic
mapping in order to locate future drill holes. The work was performed on
the Lyndall claims #20, 22, 24, 37-39 and 118-121, located in Sections
27 and 34, T23N, R50E, Eureka County, Nevada, by Fred R. Hilton, a geologist
employed by All Minerals Corporation. The cost of the field work and sample
assays exceeded one thousand dollars.

The basic findings of this study indicate that geochemical anomalies similar
to other productive areas occur within the boundary of said claims. The
samples were run for Au, Ag, Sb, As and Hg. All results from this study are
in the files of All Minerals Corporation, Murray, Utah.
