That said Deed was recorded on January 6, 1970, in Book 34, Pages 151-152, File No. 52014, Eureka County Recorder's Office.

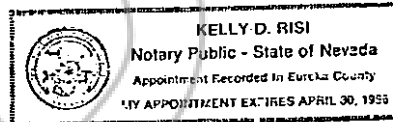
