## SURRENDER OF GEOTHERMAL LEASE

WHEREAS, HENRY M. ROLLINS and LUCIE LOE ROLLINS, as Lessors, entered into that certain Geothermal Resources Lease with AMERICAN THERMAL RESOURCES INC., a corporation as Lessee, dated June 3, 1972, hereinafter called "said Lease," a short form of which was recorded October 2, 1972, as Document No. 56741, in Book 43, Pages 471, 473, Official Records of Eureka County, Nevada; and

WHEREAS, by virtue of that certain Assignment of Lease Agreement dated June 15, 1976 recorded Eureka County, July 7, 1976 as Document No. 61624, in Book 139, Pages 375-382 and recorded in Lander County, July 1, 1976, as Document No. 083201, in Book 55, Pages 322-329, an undivided 62 1/2% of said Lease was assigned from AMERICAN THERMAL RESOURCES, INC., to CHEVRON OIL COMPANY, a corporation; and

WHEREAS, by virtue of that certain Amendment of Lease Agreement dated January 26, 1977 a short form of which was recorded June 16, 1977 as Document No. 63116, in Book 59, pages 281-283, of said Official Records, said Lease was amended as therein provided; and

WHEREAS, by virtue of that certain Assignment of Lease Agreement dated March 3, 1978, and recorded in Lander County, on March 29, 1978 as Document No. 089809, in Book 63, Pages 203-211, and in Eureka County, on April 10, 1978, as Document No. 64832, in Book 155, Pages 281-289, the remaining undivided 37 1/2% of said Lease was assigned from AMERICAN THERMAL RESOURCES, INC., to CHEVRON U.S.A. INC., a corporation, formerly CHEVRON OIL COMPANY, a corporation reserving unto Assignor a 2% overriding royalty.

NOW, THEREFORE, this instrument of Surrender WITNESSETH: That CHEVRON U.S.A. INC., does hereby terminate and Surrender all of its right,
