## ROYALTY DEED

This Royalty Deed is made and effective as of the 24th day of August, 1982, from ST. JAMES HOLDINGS, LTD., a corporation organized under the laws of the Territory of the British Virgin Islands, with principal offices at Road Town Tortola, B.V.I. (the "Grantor") to WINDFALL VENTURE, a partnership with principal offices in Grand Junction, Colorado, composed of William E. Foster, Kenneth E. Johnson, Robert G. Wilson, Chan Edmonds, and W. L. Wilson, (the "Grantee").

On August 31, 1980, Windfall Venture, the Grantee herein, conveyed and assigned to St. James Holdings, Ltd., the Grantor herein, an overriding royalty interest in certain mining claims situated in Eureka County, Nevada as are more specifically described in the said Royalty Deed which is recorded in Book 90 at Pages 311 to 317 of the Official Records of Eureka County, Nevada, reference to which recorded instrument is hereby made for all pertinent purposes.

On August 17, 1982 , Grantor entered into an Agreement for Reduction of Overriding Royalty with Western Gas, Oil & Mining, Ltd. whereunder the royalty granted by the Royalty Deed referred to in the foregoing paragraph was modified so that the royalty rate of the royalty interest held by Grantor under the said Royalty Deed was decreased from a total of 10%, such reduction to be effective as of January 1, 1983.

Grantee wishes to reacquire all of Grantor's remaining right, title and interest in the overriding royalty granted by the said Royalty Deed as reduced and modified by the above mentioned Agreement for Reduction of Overriding Royalty and Grantor is willing to assign and convey such interest to Grantee.

Accordingly, in view of the foregoing, the Grantor, for and in consideration of Ten Dollars (\$10.00) and other valuable consideration, the receipt and sufficiency of which is hereby

acknowledged, hereby bargains, sells and conveys to the Grantee and its successors and assigns, all of the right, title and interest which the Grantor may have in and to the following described patented and unpatented lode mining claims situated in the Eureka Mining District in Eureka County, Nevada:

(The above described patented claims are hereinafter referred to as the "Patented Claims", the above described unpatented claims as the "Unpatented Claims" and the Patented Claims and Unpatented Claims are referred to together as the "Mining Claims")

Grantee shall have the right to be supplied with duplicate settlement sheets from any refinery, mill, smelter or other purchaser of ores, minerals or other substances produced or derived from the Mining Claims and sold. In addition, Grantee

shall have the right to have the refiner or other buyer to which gold or silver produced from the Mining Claims is shipped, divide the overriding royalty shares of the Grantee in kind and supply Grantee's share thereof directly to the Grantee, or, at Grantee's election, to sell Grantee's shares for the account of the Grantee and to settle directly with Grantee for such sales. Grantee shall have the right at any time or from time to time to have its share of overriding royalty, herein granted and conveyed, paid directly to it by any mill, smelter or other purchaser of ores, minerals or other substances produced and sold from the Mining Claims.

The overriding royalty herein conveyed to Grantee by Grantor shall give to Grantee, its successors and assigns, the right to receive all payments for royalty and/or enforce payment thereof for any royalties which may have heretofore accrued but be unpaid to Grantor as of the effective date of this Deed as well as the right to receive and enforce payment of any royalties which may become due and payable under the interest herein transferred from and after the effective date of this instrument. The conveyance for the overriding royalty herein granted by this Deed shall attach to any right and title in the over described mining claims which Grantor may presently possess and which Grantor may hereafter acquire. The said overriding royalty herein conveyed shall attach and pertain to the said mining claims, above described, and/or any amended locations or relocations thereof. In addition, the said overriding royalty herein conveyed shall attach to any other mining claims or other properties which may be located by Western Gas, Oil & Mining, Ltd. or any other person or entity acting by, through or on behalf of said company, within 600 feet of the exterior boundaries of the above described mining claims.

This Deed shall be binding upon Grantor, its successors and assigns and shall inure to the benefit of Grantee, and its successors and assigns.
