That the Certificate of Location of each and all of the above-named claims have been filed for record in the office of the County Recorder of Eureka County, in the town of Eureka, and the Nevada BLM in the City of Reno, and such certificates are hereby referred to, and by such reference made a part hereof for all particulars therein shown. That the claims indicated as "Relocated" had been abandoned and were relocated on September 1, 1983; that the recording information and BLM serial numbers shown are for the abandoned claims and relocation certificates for these claims will be timely recorded with Eureka County and filed with BLM.

That said labor was performed during the period between September 1, 1982 and September 1, 1983. That such work performed to advance the development of said claims consisted of 3,950 linear feet of trenching. Maximum depth of trenches was 14 feet with average depth of 4 feet. The trenching was done on the claims known as Afgan Nos. 5, 7, 9, 11 and relocated claims known as Afgan Nos. 13, 15, 17, 19, 21, 69, 70 and 71. The trenching was performed by Nevin Munson & Son, Inc. of Ely, Nevada. The total amount expended exceeds \$100.00 on or for each claim.

That such work, including the work done on the subsequently relocated claims, was done and performed for the development and benefit of each and all of the unpatented lode mining claims, all being contiguous. That all expenditures were made by or for Lyle F. Campbell and/or others for the purpose of complying with the laws of the United States and of the State of Nevada in the performance of annual assessment work to maintain title to unpatented lode mining claims; that said work was done by or for and on behalf of and for the benefit of the above-named owner of the unpatented lode mining claims.
