Holmes, being first duly sworn, deposes and says that he is a citizen of the United States and more than twenty-one (21) years of age, and resides in Lakewood, County of Jefferson, State of Colorado, and is personally acquainted with the PILL lode mining claims situated in the Unnamed Mining District, Eureka County, Nevada, the names and books and pages of record in the office of the County Recorder of Eureka County, Nevada, and the Bureau of Land Management serial number of the Certificate of Location whereof are as indicated in Exhibit A attached hereto and made a part thereof.
