

Certificate of Location of Lode Mining Claim

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies (certify) that he (she, they) has (have) located the Aerie #33 Lode Mining Claim in Section 12, Township 27N, Range 49E in the unorganized Mining District, in Eureka County, in the State of Nevada, on the 7th day of August, 1983.

The claim is 1500 feet long and 600 feet wide, and 750 feet is claimed in a Northerly direction and 750 feet in a Southerly direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the Northeast to the Southwest.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by 4" x 5' PVC Pipe ink inscribed.
