THIS IS TO CERTIFY that the CC # 13 lode mining claim was located by:

Beginning at Corner No. 1, the Northeast corner, which is located 500 feet north and 1500 feet east from the southwest corner of Sec. 32, Twp. 35 North, Range 52 East , Mount Diablo Meridian; thence,

south 600' to the SE corner, A 4" PVC pipe x 5' long; thence,
west 750' to the south side center, a 4" PVC pipe x 5' long; thence,
west 750' to the SW corner, A 4" PVC pipe x 5' long; thence,
north 600' to the NW corner, " " " " "; thence,
east 750' to the north side center, a 4" PVC pipe x 5' long; thence,
east 750' to the NE corner, A 4" PVC pipe x 5' long; the point and place of beginning.

We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 10 feet from the location monument in a easterly direction, and 1490 feet in a westerly direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The monumentation and marking of the corners was completed by the 8th day of September, 1983.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Elko County Recorder, and the \$20.75 lode claim filing fee has been paid to the County Recorder.
