GRANT, BARGAIN AND SALE DEED

THIS INDENTURE, made and entered into this 19th day of September, 1983, by and between SLAGOWSKI RANCHES, INC., a Nevada corporation, Grantor, and LEO DAMELE AND SONS RANCHES, INC., a Nevada corporation, whose address is Pine Valley, Carlin, Nevada 89822, Grantee;

W I T N E S S E T H:

That the said Grantor, for and in consideration of the sum of TEN DOLLARS (\$10.00), lawful money of the United States of America, to it in hand paid by the Grantee, and other good and valuable consideration, the receipt whereof is hereby acknowledged, does by these presents, grant, bargain, sell, and convey unto the said Grantee, and to its successors and assigns, all those certain lots, pieces, or parcels of land situate, lying, and being in the County of Eureka, State of Nevada, and more particularly described as follows, to-wit:

See Exhibit "A", attached hereto and made a part hereof.

TOGETHER WITH the following for, on or appurtenant to any or all of the above-described lands:

The tenements, hereditaments and appurtenances thereunder belonging or in anywise appertaining, and the reversion and reversions, remainder and remainders, rents, issues and profits of said ranch lands.

All buildings, cow camps, fixtures, fences and improvements thereon.

All springs, wells, water and water rights adjudicated, appropriated, decreed, vested or appurtenant to each parcel including all permits, certificates, applications, proofs, logs, maps and agreements therefor, and all dams, ditches, diversions, headgates, measuring devices, ponds, reservoirs, canals, pipelines, well casings, well pumping equipment, troughs and all other means, methods, systems of using water and water rights and applying them to beneficial use on each parcel and including but not limited to all domestic water rights and irrigation water rights and all stockwater and stockwater rights for use on the described lands, and all easements, therefor and agreements relating thereto, with the right to use, maintain, clean, rebuild, and repair them by use of modern equipment and methods.

Determination of the Relative Rights of Claimants and Appropriators of the Waters of the Humboldt River Stream and Tributaries", and by any subsequent court orders, judgments, or decrees amending or modifying such Bartlett Decree, including but not limited to the following:

1. The right to divert 391.11 ac. ft. of water flowing in Pine Creek for the irrigation of 138.51 acres as allotted to W.S. Yates in the 1943 "Blue Book" compilation of the Humboldt River Adjudication - Page 156, and in Proof #00305.
 2. The right to divert 1,233.55 ac. ft. of water flowing in Pine Creek for irrigation of 416.74 acres as allotted to C.H. Rand in the 1943 "Blue Book" compilation of the Humboldt River Adjudication - Page 156 in Proof #00306.
 3. The right to divert 172.07 ac. ft. of water from Trout Creek for the irrigation of 163.45 acres as allotted to C.H. Rand in the Humboldt River Adjudication - Page 156, and in Proof #00306.
- B. The right to divert 7.848 c.f.s. of underground water from a well for the irrigation of 470.5 acres of land, and for domestic purposes, evidenced by Certificate of Appropriation of Water No. 6181 (Application No. 19123) issued by the Nevada Division of Water Resources.

All easements, rights of way and licenses benefiting or appurtenant to or used in connection with said lands, or any of them, and to the public land and state land grazing areas, including but not limited to use for access.

All corrals, fences, gates, cattleguards, culverts, stockwater troughs, water tanks, and pipelines and stockwater, irrigation and domestic water systems on said lands.

All rights, privileges, preferences, term permits and leases to graze livestock on the public lands administered by the Bureau of Land Management, based, apportioned and attached to the above-described lands or water rights or both, with all range improvements and stockwater rights on the public lands grazed pursuant to these preferences and the cooperative agreements and permits therefor.

All right, title, interest and estate Grantor has in and to all geothermal resources, geothermal energy, coal, oil, gas, oil shale, metals and minerals of every kind and nature whatsoever (including, but not limited to barium sulfate, uranium, fissionable materials, metals, tungsten, tin, lead, zinc,

copper, gold, silver and other minerals), existing upon, beneath the surface of, or within the above-described lands, and all mines thereof, with all leases, rentals, royalties, and other consideration therefor.

Together with any and all reversion and reversions Grantor may have pursuant to the Mineral Deed dated June 30, 1981, recorded July 6, 1981 in Book 96, Page 14, Official Records, Eureka County, Nevada from John D. Rand and Martha A. Rand.

TO HAVE AND TO HOLD the said premises, together with the appurtenances, unto the said Grantee, and to its successors and assigns, forever.

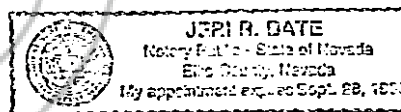
