were made on approximately 460 samples by  
GEXA. The purpose of this survey was to  
correlate existing mineral discoveries on each claim with anomalous

the most efficient development of the mineral resources on these  
claims.

IV. That the labor was performed and the improvements made  
between August 17, 1983 to August 28, 1983  
eleven days of work were done upon and for the benefit of

V. That GEXA expended more than  
\$6,600 dollars for the work and improvements.

VI. That the basic findings of this survey are as follows:  
The analytic results of the geochemical program, plotted on maps  
of appropriate scale and correlated with the bedrock geology, form  
anomalous patterns of sufficient magnitude, shape and areal extent  
to justify and encourage further and more extensive development work  
on each and all of the above-named claims. The individual analyses

IX. That the work as herein described was done for the benefit of all the claims described in Paragraph I above at a total cost of more than \$6,600.

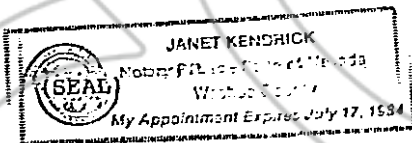
