

Certificate of Location of Lode Mining Claim

The claim is 1500 feet long and 600 feet wide, and 50 feet is claimed in a southerly direction and 1450 feet in a northerly direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 100' westerly & 500' easterly of the middle of vein. The general course of the lode deposit and premises is from the N01°-05'-10"E to the S01°-05'-10"W.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by aluminum tag.
