 and under all of the terms and provisions of said lease, and as to said land, do hereby agree and declare that said lease is now
 in full force and effect; that payment has been duly made of the entire bonus consideration and all of the delay rentals
 necessary to extend said lease to the next rental paying date; and each of the undersigned agrees that any delay rentals which
 may be paid under the terms of said lease with respect to the above described land may be divided as follows:
