

CERTIFICATE OF LOCATION OF LODE MINING CLAIM

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies that he has located the D. Lake 226 Lode Mining Claim in SE $\frac{1}{4}$ NE $\frac{1}{4}$ Sec. 2, Township 18 North, Range 52 East in the Unknown Mining District, in Eureka County, in the State of Nevada, on the 1st day of September, 1983.

The general course of the lode deposit and premises is from the North to the South.
