

CERTIFICATE OF LOCATION OF LODE MINING CLAIM

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies that he has located the D. Lake 287 Lode Mining Claim in SW $\frac{1}{4}$ Sec. 12, Township 18 North, Range 52 East in the Unknown Mining District, in Eureka County, in the State of Nevada, on the 1st day of September, 1983.

The claim is 1500 feet long and 600 feet wide, and 1480 feet is claimed in a North direction and 20 feet in a South direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the North to the South.
The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by scribed metal tags
