

## CERTIFICATE OF LOCATION OF LODE MINING CLAIM

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies that he has located the D. Lake 336 Lode Mining Claim in NW 1/4 Sec. 1, Township 18 North, Range 52 East in the Unknown Mining District, in Eureka County, in the State of Nevada, on the 1st day of September, 1983.
