

CERTIFICATE OF LOCATION
(Lode)Richmond #33

Lode Mining Claim.

This is to certify that the above-named claim was located by the undersigned locator on the 47th day of November, 1983. The claim is situated within the 1/4 of Section 12 of Township 12th, Range 33^E, M.D.M., UNSUBDIVIDED and within the Eureka Mining District, Eureka County, Nevada.

The general course of the lode or vein is North and South. The locator claims 1430 feet along the course of the vein, 1430 feet in a South direction and 50 feet in a North direction from the point of discovery, together with 300 feet on either side of the center of the vein.

Within 20 days after posting notice on the ground, the locator defined the boundaries of the claim as required by law and established monuments, consisting of posts at least four inches in diameter by four-and-one-half feet in length set firmly in the ground, at the point of discovery, at each corner, and at the sideline centers. Each monument is marked (or contains markings) with the name of the claim and designation of the particular monument.

The metes and bounds of this claim is as follows: From a natural object, permanent monument or public survey corner known as SW corner Sec. 12 Twp 33 E 10 900 feet in a SE direction to Corner No. 1 (the NE corner), the point of beginning; thence in a South direction through the EST sideline center 1430 feet to Corner No. 3 (the SE 1 corner); thence in a west direction 580 feet to Corner No. 7, (the SW 1 corner); thence in a North direction through the West sideline center 1430 feet to Corner No. 6 (the NW 1 corner); thence in a East direction 580 feet to Corner No. 1, the point of beginning.

The location work, consisting of the making of maps, and the filing of said maps and the payment of the fees required by NRS 517.040, were completed by the date of recordation of this certificate.
