The undersigned hereby certifies that he has caused to be located the Sage 28 lode mining claim in the following quarter section(s): SE $\frac{1}{4}$ and NE $\frac{1}{4}$ of Sections 25 and 36, Township 27 North, Range 48 East, M.D.B.&M., in the Buckhorn Mining District, in Eureka County, in the State of Nevada, on the 12th day of October, 1983.

The Claim is 1,200 feet long and 400 feet wide, such that 50 feet is claimed in a northeasterly direction and 1,150 feet in a southwesterly direction from the discovery monument, at which the Notice of Location is posted, lengthwise of the Claim, together with 200 feet on each side of the discovery monument and centerline of the Claim. The general course of the lode deposit and premises is from the northeasterly to southwesterly direction.

The definition of the boundaries of the Claim, together with the erection of boundary or corner monuments and the marking of such monuments, was completed by the 22nd day of October, 1983.
