The undersigned hereby certifies that he has caused to be located the Sage 101 lode mining claim in the following quarter section(s): NW $\frac{1}{4}$ of Section 19, Township 27 North, Range 49 East, M.D.B.&M., in the Buckhorn Mining District, in Eureka County, in the State of Nevada, on the 5th day of October, 1983.

The Claim is 900 feet long and 600 feet wide, such that 50 feet is claimed in an easterly direction and 850 feet in a westerly direction from the discovery monument, at which the Notice of Location is posted, lengthwise of the Claim, together with 300 feet on each side of the discovery monument and centerline of the Claim. The general course of the lode deposit and premises is from the westerly to easterly direction.

The definition of the boundaries of the Claim, together with the erection of boundary or corner monuments and the marking of such monuments, was completed by the 15th day of October, 1983.
