The Claim is 1,456.57 feet long and 200 feet wide, such that 200 feet is claimed in a southwesterly direction and 1,256.57 feet in a northeasterly direction from the discovery monument, at which the Notice of Location is posted, lengthwise of the Claim, together with 100 feet on each side of the discovery monument and centerline of the Claim. The general course of the lode deposit and premises is from the northeasterly to southwesterly direction.

The definition of the boundaries of the Claim, together with the erection of boundary or corner monuments and the marking of such monuments, was completed by the 15th day of October, 1983.
