

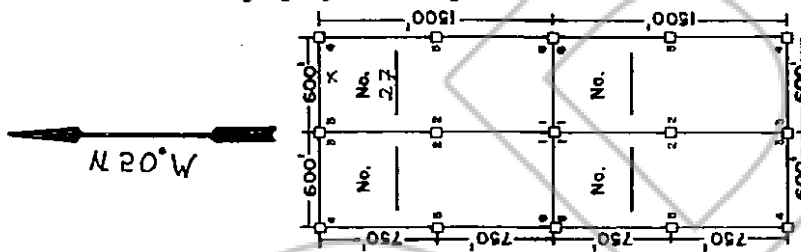
NOTICE IS HEREBY GIVEN that the Selrat No. 27 lode mining claim is hereby amended as the Selrat No. 27 lode mining claim. This claim was located by Amselco Exploration Inc., a Delaware corporation, whose address is 90 West Grove Street, Suite 100, Reno, Nevada 89509 on the 28 day of March, 1979, and a copy of the location certificate is of record in the office of the Recorder of Eureka County, Nevada in Book 70, Page 509. The general course of this claim is N20°W. This claim is 1500 feet in length along the course of the claim, being 10 feet from the point of discovery in a N20°W direction to the NW end line of the claim, and 1490 feet in a S20°E direction to the SE end line of the claim. This claim is 600 feet in width, being 300 feet in width on each side of the center line of the claim.

This claim is located all or in part of the following quarter Sections(s), Township(s), and Range(s):

The claim location marker SR-1 is located approximately: 1.93 miles N76°E from Gray's Peak; 2.5 miles N8°E from South Hill Peak; 0.55 miles S27°W from Surprise Peak
