The claim is 1450 feet long and 550 feet wide, and 25 feet is claimed in a SOUTH direction and 1425 feet in a NORTH direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 225 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the North to the South.

Corner No. 5 is a 4 $\frac{1}{2}$ ' x 4" x 4" wood post, the W Side Center

Corner No. 6 is a 4 $\frac{1}{2}$ ' x 4" x 4" wood post, the NW corner

The monumentation and marking of the corners was completed by the 18th day of September, 1983.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
