

CERTIFICATE OF LOCATION OF LODE CLAIM

THIS IS TO CERTIFY THAT THE SADIE 12 Lode Mining Claim was located by Windfall Venture, a partnership, whose post office address appears below, on the 21st day of August, 1983.

The general course of said lode or vein is $N10^{\circ} E$. The claim is situate in the Secret Canyon area of the Eureka (unorganized) Mining District, Eureka County, Nevada.

The Locator claims 10 feet $N25^{\circ}20'W$ and 1490 feet $S25^{\circ}20'E$ from the location monument, and a width of 300 feet on each side of the center of the vein or lode along the entire length of said claim.

In compliance with Section 517.040, 517.050 and other applicable portions of the NEVADA REVISED STATUTES, a map was prepared and recorded with the Eureka County Recorder.

Each corner and side center of said claim is marked with an aluminum or plastic pipe, 4" in diameter, 4½ feet long, set one foot of its length in the ground, said posts being located and marked (markings are on metal tags affixed to said posts) as follows:

"NW COR Sadie 12 "; thence $N64^{\circ}40'E$ for a distance of 600 feet to a post marked, "North East Corner Sadie 12 "; thence $S25^{\circ}20'E$ for a distance of 750 feet to a post marked "East Side Center Sadie 12 "; thence, $S25^{\circ}20' E$ for a distance of 750 feet to a post marked "SE Corner Sadie 12 "; thence $S64^{\circ}40' W$ for a distance of 600 feet to a post marked "South East Corner Sadie 12 "; thence $N25^{\circ}20' W$ for a distance of 750 feet to a post marked "West Side Center Sadie 12 "; thence $N25^{\circ}20' W$ for a distance of 750 feet to the point of beginning.

This claim lies mostly within the $SE \frac{1}{4}$ of Section 15, T 18 N., R. 53 E., MDB&M, (unsurveyed, but described according to the protraction diagram of such Township) Eureka County, Nevada. The NW Corner of this claim is approximately 14,360 feet South and 6,340 feet West of the SW Corner of Section 36, T. 19 N., R. 53 E, MDB&M.

All location and discovery work necessary to complete this location have been performed by October 3, 1983.
