mineral content contained therein.

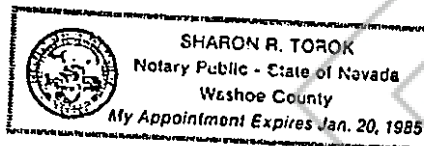


