## NOTICE OF LOCATION

(SECTS. 2301 TO 2324, PUBLIC RESOURCES CODE)

TO WHOM IT MAY CONCERN: Please take notice that:

1. The name of this claim is the FIVE-O NO. 3 Lode Mining Claim. Said claim is situated in the UNION Mining District, County of EUREKA, State of NEVADA. Located this 4 (FOURTH) day of DECEMBER, 1883, when discovery was made and copy of the original notice posted.

2. That the undersigned locators are citizens of the United States or have declared their intention to become such, and have discovered mineral bearing rock in place thereon and do locate and claim same for mining purposes.

3. That the number of linear feet in length along the course of the vein each way from the point of discovery whereon we have erected a monument, is EAST 10 feet; WEST 1490 feet; that the total length does not exceed 1500 feet. That the width on the NORTH Westerly side is 520 feet; that the width on the SOUTH Westerly side is 80 feet; that the total width does not exceed 600 feet, that the end lines are parallel; that the general course of the vein or lode as near as may be, is to a EAST Westerly and WEST Westerly direction; that the boundaries of this claim may be readily traced, and are defined as follows, to-wit:

COMMENCING at 10 FEET in a EAST Westerly direction from the discovery monument, 1490 feet therefrom, to its WESTERN MOST EXTENT, 520 FEET to its NORTHERN LIMIT, AND 80 FEET to its SOUTHERN BOUNDARY. THIS MONUMENT LIES APPROXIMATELY 1500 FEET S.E. OF BRUFFY RANCH (SECTION 14/13 BOUNDARY), AND APPROXIMATELY 50 FT. NORTH OF THE BRUFFY CANYON (COUNTY) ROAD; OFF THE SECTION 13/24 BOUNDARY LINE.

4. That this claim can be identified by its proximity to the following natural object or permanent monument, to-wit: S.E. CORNER SECTION 13; T27N, R52E.

This notice is intended as an original notice of location and is posted on this claim and a true copy thereof is to be recorded with the County Recorder of this County, EUREKA.

That all the dips, variations, spurs, angles and all veins, ledges, or deposits within the lines of this claim, together with all water and timber and any other rights appurtenant, allowed by the law of this State or of the United States are hereby claimed.
