The claim is 1500 feet long and 600 feet wide, and 571 feet is claimed in a Westerly direction and 1450 feet in a Easterly direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the West to the East.

 Corner No. 6 is a 4" Dia. P.V.C. Pipe (5ft Length) - Brown Color

The monumentation and marking of the corners was completed by the 13th day of December, 1983.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
