Said locator is the proprietor of the Buckhorn Nos. 1-9, D & D Fraction, Narrow Gauge, and Easter Nos. 1 and 2 patented mining claims generally located in the Buckhorn Mining District, in Eureka County, State of Nevada.

Corner No. 1, the northwest corner of the Millsite Claim, is a common point with the northeast corner of the Buckhorn 18 Millsite Claim.

The Millsite Claim is a parallelogram of 1,452.0 feet in the north-south direction and 150.0 feet in the east-west direction. Said Millsite Claim contains 5.0 acres, more or less.

The definition of the boundaries of the Millsite Claim, together with the erection of boundary or corner monuments, and the marking of such monuments, was completed by the 19 day of December, 1983.
