EXCEPTING THEREFROM each and every parcel of land above described all petroleum oil, natural gas and products derived therefrom, and all rights thereto, together with the exclusive right at all times to enter upon or in said land to prospect for, and to drill for, recover and remove the same, as the same has heretofore been excepted and reserved by the Southern Pacific Land Company, a corporation, for itself and its successors and assigns, by deed recorded March 9, 1950, in Book 24 of Deeds, page 42, Eureka County Records.

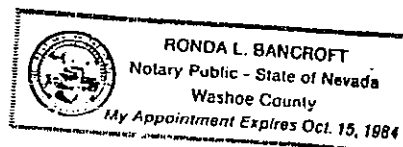
