

CERTIFICATE OF LOCATION

THE UNDERSIGNED hereby certifies that ATLAS CORPORATION, by its agent, the undersigned, has located a mining claim in the UNKNOWN Mining District, County of EUREKA, State of Nevada, on a vein or lode known as the JASPER 118.

Said claim was located on the 27TH day of OCTOBER, 19 83.

The locator claims 1500 linear feet in length in a NORTH/SOUTH direction along the course of said vein or lode running 1490 feet NORTH and 10 feet SOUTH, from the point of location at which this location certificate is posted, with a width of 300 linear feet on each side of the center of the vein or lode along the entire length of said claim.

The location work consisted of making the map as provided in NRS 517.040. Dated NOVEMBER 15, A.D., 19 83, and filed in duplicate.

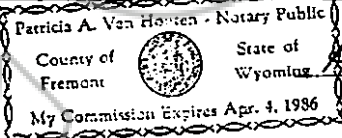
