CERTIFICATE OF LOCATION

THE UNDERSIGNED hereby certifies that ATLAS CORPORATION, by its agent, the undersigned, has located a mining claim in the UNKNOWN Mining District, County of EUREKA, State of Nevada, on a vein or lode known as the JASPER 127F.

Said claim was located on the 9TH day of NOVEMBER, 19 83.

The locator claims 840 linear feet in length in a EAST/WEST direction along the course of said vein or lode running 830 feet EAST and 10 feet WEST, from the point of location at which this location certificate is posted, with a width of 100 linear feet on each side of the center of the vein or lode along the entire length of said claim.

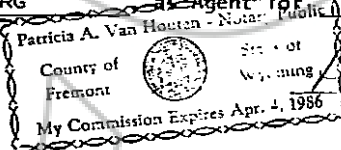
