

CERTIFICATE OF LOCATION

THE UNDERSIGNED hereby certifies that ATLAS CORPORATION, by its agent, the undersigned, has located a mining claim in the UNKNOWN Mining District, County of EUREKA, State of Nevada, on a vein or lode known as the JASPER 167.

Said claim was located on the 27TH day of OCTOBER, 19 83.

The location work consisted of making the map as provided in NRS 517.040. Dated NOVEMBER 15, A.D., 19 83, and filed in duplicate.


