We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 1450 feet from the location monument in a Northerly direction, and 50 feet in a Southerly direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.
