We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge,  
lode or vein, extending 1450 feet from the location monument in a Northerly  
direction, and 50 feet in a Southerly direction, together with 300 feet  
on each side of the center of the ledge for the entire length of the claim.

The monumentation and marking of the corners was completed by the 19th day of
