

LOCATION CERTIFICATE--NEVADA

KNOW ALL MEN BY THESE PRESENTS, That Atlantic Richfield Company, a Pennsylvania Corporation, acting through its division, Anaconda Minerals Company, by its Agent, the undersigned, hereby located the BR #34 Lode Mining Claim on this 24th day of October, 1983, situated in the Unknown Mining District, Eureka County, Nevada, and by this certificate, and by right of discovery and location, claim 1500 feet, linear and horizontal measurement along the lode thereof, said lode running 1490 feet in a Northerly direction from the point of discovery and 10 feet in a Southerly direction from the point of discovery, together with 300 feet on either side of the middle of said lode at the surface. The discovery monument, a 4" diameter x 4 1/2' post, on which notice of this claim is posted is located at said point of discovery.

Said Claim is located in the NE 1/4, NW 1/4, SE 1/4 & SW Quarter, Section 13, Township 27 North, Range 52 East, Mount Diablo B & M, and is more particularly described by metes and bounds as follows, to wit:

Beginning at Northwest corner post No. 1, marked NW Corner,

Thence 600 feet in an Easterly direction to a 4" diam. x 4 1/2' long post, Corner No. 2, marked Northeast Corner,  
Thence 750 feet in a Southerly direction to a 4" diam. x 4 1/2' long post, Corner No. 3, marked East Side Center,  
Thence 750 feet in a Southerly direction to a 4" diam. x 4 1/2' long post, Corner No. 4, marked Southeast Corner,  
Thence 600 feet in a Westerly direction to a 4" diam. x 4 1/2' long post, Corner No. 5, marked Southwest Corner,  
Thence 750 feet in a Northerly direction to a 4" diam. x 4 1/2' long post, Corner No. 6, marked West Side Center,  
Thence 750 feet in a Northerly direction to a 4" diam. x 4 1/2' long post, Corner No. 1, point of beginning, the boundaries set the 10th day of November, 1983.

To tie this Claim to the Public Land Survey, begin at the Southwest Corner, Section 13, Township 27 North, Range 52 East, Mount Diablo B & M, bear 3000 feet North and 2400 feet East to the Northwest corner, No. 1 of this claim. Location work includes preparation and recording of a map of this claim and contiguous claims and such map is hereby incorporated by reference.

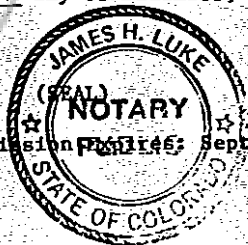
