THIS IS TO CERTIFY that the Ruth # 10 lode mining claim

We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 1480 feet from the location monument in a southerly direction, and 20 feet in a northerly direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a PVC post 4 feet high, inscribed "NW Corner of the Ruth # 10 Claim;" the southwest corner is marked by a PVC post 4 feet high, inscribed "SW Corner of the Ruth # 10 Claim;" the southeast corner is marked by a PVC post 1 feet high, inscribed "SE Corner of the Ruth # 10 Claim;" the northeast corner is marked by a PVC post 4 feet high, inscribed "NE Corner of the Ruth # 10 Claim." There is also a PVC post 4' at the center of each side line.

The monumentation and marking of the corners was completed by the 19 day of Nov, 1983
(must be within 30 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
