**GENERAL CONVEYANCE
OF
OIL, GAS AND MINERAL INTERESTS**

THIS CONVEYANCE from NATOMAS NORTH AMERICA, INC., a California corporation, successor by merger to Apexco, Inc. formerly named Apache Exploration Corporation, whose address is 1155 Dairy Ashford, Houston, Texas 77079 (herein called "Grantor"), to APC OPERATING PARTNERSHIP, a Texas limited partnership of which Apache Corporation, a Delaware corporation, is the sole general partner and Apache Petroleum Company, a Texas limited partnership, is the sole limited partner, whose address is Foshay Tower, Minneapolis, Minnesota 55402 (herein called "Grantee"), which is delivered and effective at 12:01 a.m. local time at the respective locations of the Subject Interests (as hereinafter defined) on March 9, 1984 (the "Effective Time");

WITNESSETH:

Grantor, in consideration of One Hundred Dollars (\$100.00) cash and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, does hereby GRANT, BARGAIN, SELL, CONVEY, ASSIGN, TRANSFER, SET OVER and DELIVER unto Grantee all of the following:

A. All right, title and interest of Grantor in and to the oil and gas leases, oil, gas and mineral leases, leasehold interests, fee mineral interests, royalty interests, overriding royalty interests, production payments, net profits interests, carried interests and other oil, gas or mineral interests, rights and properties in, to and under the leases and lands which are specifically described or referred to in Exhibit A attached hereto and made a part hereof for all purposes; subject, however (to the extent and only to the extent that the same are valid and subsisting at the Effective Time), to any restrictions, exceptions, reservations, conditions, limitations, burdens, contracts, agreements and other matters, applicable to such leases, interests, rights and properties;

B. All right, title and interest of Grantor in, to and under, or derived from, all presently existing and valid oil, gas or mineral unitization, pooling, operating

and communitization agreements, declarations and orders, and in and to the properties covered and the units created thereby (including all units formed under orders, regulations, rules or other official acts of any federal, state or other governmental agency having jurisdiction), which relate to or affect any of the leases or lands specifically described or referred to in Exhibit A;

C. All right, title and interest of Grantor in, to and under, or derived from, all presently existing and valid oil and gas sales, purchase, exchange and processing contracts, casinghead gas contracts, operating agreements, joint venture agreements, partnership agreements and other contracts, agreements and instruments which relate to or affect any of the leases or lands specifically described or referred to in Exhibit A;

D. All right, title and interest of Grantor in and to all personal property, improvements, lease and well equipment, easements, permits, licenses, servitudes, rights-of-way, surface leases and other surface rights (including, but not by way of limitation, any wells, tanks, boilers, buildings, gas processing plants, fixtures, machinery, injection facilities, saltwater disposal facilities, compression facilities and other equipment, gathering systems, power lines, telephone and telegraph lines, roads and other appurtenances, facilities and easements), being used in connection with the exploration, development, operation or maintenance of the leases or lands specifically described or referred to in Exhibit A, or any unit or units in which part or parts of such leases or lands may be included, or being used in connection with the production, treating, storing, gathering, transportation or marketing of oil, gas and other minerals produced from or allocated to such leases or lands or such unit or units (herein called the "Appurtenant Interests");

E. Without limitation of the foregoing, all right, title, interest and estate of Grantor of every nature and description in and to the leases and lands specifically described or referred to in Exhibit A or included in any unit including any of Grantor's interest in any such lease or land specifically described or referred to in Exhibit A, even though Grantor's interests therein be incorrectly described in, or a description of such interests be omitted from, Exhibit A, and all right, title, interest and estate held of record or otherwise by Grantor for the benefit of Apache Corporation or any affiliate of Apache Corporation as successor in interest to Apexco, Inc. formerly named Apache Exploration Corporation, in and to the leases and lands specifically described or referred to in Exhibit A or included in any unit including any

such interest in any such lease or land specifically described or referred to in Exhibit A; and

F. Without limitation of the foregoing, all right, title, interest and estate of Grantor of every nature and description, if any, in and to any additional oil, gas and/or mineral leases covering, and any other oil, gas and/or other mineral interests in, any land within the United States of America or offshore the United States of America (and within the jurisdictional limits thereof) and which is not otherwise described in or covered by any of paragraphs A, B or E above;

EXPRESSLY EXCEPTING AND EXCLUDING, however, from this Conveyance the following specific properties, assets and rights:

(a) All right, title and interest of Grantor in and to all United States oil and gas leases located on the Outer Continental Shelf, or interests therein;

(b) All oil and gas properties and interests not located in the United States (or within the jurisdictional limits thereof);

(c) All leases and subleases of office space, and all office furniture, fixtures, equipment and supplies, and all vehicles wherever located; and

(d) All inventories of tubular goods and other supplies and tools (other than inventories of tubular goods, supplies or tools that have been specifically identified on Grantor's records prior to the Effective Time for use with respect to specific projects related to exploration, development or production operations on the Subject Interests) and all patent rights and trademarks.

All of the foregoing leases, interests, rights and properties described in paragraphs A through F above, subject to the exceptions and reservations as aforesaid, are herein called the "Subject Interests".

Grantee hereby assumes and agrees to perform and be bound by all of the contractual duties and obligations of Grantor as owner of the Subject Interests to the extent that the same are valid and subsisting at the Effective Time.

This Conveyance is made without any covenant or representation of title or warranty of title of any kind, express or implied, and without any recourse against Grantor, not even for the return of the consideration paid, but is made with full substitution and subrogation of Grantee in and to all covenants and warranties by others heretofore given or made with respect to the Subject Interests or any part thereof. GRANTOR MAKES NO REPRESENTATIONS OR WARRANTIES, EITHER EXPRESS OR IMPLIED, AS TO THE MERCHANTABILITY, QUALITY, CONDITION OR FITNESS FOR PARTICULAR USES OF ANY OF THE APPURTENANT INTERESTS, ALL OF THE SAME BEING HEREBY EXPRESSLY EXCLUDED AND DENIED.

In confirmation of this Conveyance, Grantor may hereafter execute and deliver separate conveyances and assignments of certain of the Subject Interests which, or interests in which, comprise interests in lands of (i) the United States of America, (ii) one or more States or agencies thereof, or (iii) Indian tribes, bands or groups or of Indians to whom lands have been allotted in severalty, upon approved forms in sufficient counterparts to fulfill applicable statutory and regulatory requirements and such separate conveyances or assignments, although unqualified in form and not specifically containing all the terms and provisions hereof, shall nevertheless be deemed to contain all of the exceptions, exclusions, limitations and provisions set forth in this Conveyance as fully to all intents and purposes as though the same were set forth at length in such separate conveyances and assignments. In addition, Grantor agrees to execute and deliver to Grantee all such other and additional instruments, notices, division orders, transfer orders and other documents and to do all such other and further acts and things as may be necessary to more fully and effectively grant, convey and assign to Grantee the rights, titles, interests and estates in the Subject Interests conveyed hereby or intended so to be.

This Conveyance is being executed in multiple originals, all of which are identical, except that, to facilitate recordation, in certain counterparts hereof only that portion of Exhibit A which contains specific descriptions of Subject Interests located in the recording jurisdiction where that counterpart is to be recorded are included, and other portions of Exhibit A are included by reference only. All of such counterparts together constitute but one and the same instrument. Complete copies of this Conveyance containing the entire Exhibit A have been retained by Grantor and Grantee.
