

## AMENDMENT OF PARTIAL ASSIGNMENT

Shell Western E&P Inc., herein called "SWEPI" and Hunt Oil Company of Nevada, herein called "Hunt", agree that the Partial Assignment dated January 11, 1984, covering the oil, gas and mineral lease described in Exhibit "A" covering lands located in Eureka County, Nevada and recorded in Book 121, Page 319 of said county records, which assignment was made pursuant to our Agreement dated May 1, 1980, shall be amended as follows:

The subject Partial Assignment which conveyed an undivided twenty-five percent (25%) of SWEPI's right title and interest in that oil, gas and mineral lease contained on Exhibit "A" to Hunt Oil Company shall be amended to make said assignment from Shell Western E&P Inc. to Hunt Oil Company of Nevada, rather than to Hunt Oil Company.

Whereas, this Amendment of Partial Assignment is not intended hereby to supercede or novate said Partial Assignment but said Partial Assignment, as herein amended, shall continue in force as though the name Hunt Oil Company of Nevada had been contained in said Partial Assignment when originally executed.
