The general course of the lode deposit and premises is from the East to the West.

The monumentation and marking of the corners was completed by the 4th day of April, 1984.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
