The general course of the lode deposit and premises is from the North to the South.

Corner No. 6 is a 4" x 4" x 4 $\frac{1}{2}$ " wooden post

The monumentation and marking of the corners was completed by the 4th day of April, 19 84.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
