The claim is 1500 feet long and 600 feet wide, and 20 feet is claimed in a Westerly direction and 1480 feet in a Easterly direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the East to the West.

The monumentation and marking of the corners was completed by the 4th day of April, 1984.
