To have and to hold the said properties unto grantees as their community property, and to their heirs, successors and assigns, forever.

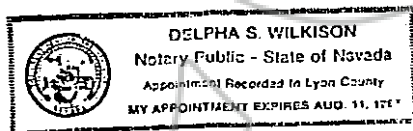
