
TO HAVE AND TO HOLD the said premises, together with the appurtenances unto the said party of the second part, as his sole and separate property, and to his heirs and assigns forever.



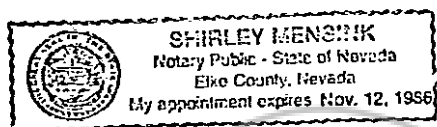


